6. **Hot Topics:** Our new "Wildfire survey" for 2023 will launch on May 20; Getting homeowners to commit to making their property part of the wildfire solution; and protecting valuables.
7. **Future Schedule:** Should you become CERT trained?, Our June INSURANCE special event, and an update on high fire severity maps in CA (coming from CalFire).
