3. **BRIEF REPORT ON THE MOUNTAIN FIRE (CAN IT HAPPEN IN L.A.):** MySafe:LA members arrived at the Mountain Fire within 90 minutes of the initial 911 call. Our members also helped residents manage their situation following the fire's extinguishment. We'll share a brief report and explain how this fire could impact Los Angeles.
4. **LOS ANGELES WILDFIRE PROTECTION PLAN PUBLIC INPUT:** MySafe:LA is developing a strategy to minimize wildfire risk in the city. This initiative is crucial for all residents in the wildland-urban interface. In this presentation, we will outline the plan's development and invite you to provide feedback online. *Your insights are essential to helping us achieve our established goals.* The "open feedback" period will continue through January 12, 2025.
5. **STATE FIRE INSURANCE UPDATE:** The California Department of Insurance is close to completing its new policies regarding insurance availability, underwriting, and support for California residents. We'll provide a quick update.
6. **INITIAL 2025 WILDFIRE OUTLOOK:** The threat of wildfires affecting Los Angeles is on the rise. So, what can we anticipate for wildfires in L.A. by 2025? We will share some preliminary thoughts and offer suggestions on mitigating risks in the upcoming year.
7. **Fire Safe Council Announcements:** At our January 16, 2025 meeting, we will announce some progress in NFPA Firewise in L.A. and Fire Safe Council applications.
